

UNEMPLOYMENT COMPENSATION (UC) AMNESTY FORM

From June 1, 2013, through August 31, 2013, Pennsylvania is offering amnesty to employers who owe UC taxes. Generally, the Amnesty Program allows employers to receive 50% off of the amount of interest and penalties owed on contributions that were due on or before April 30, 2012, provided the contributions are fully paid. Please fill in the amounts you are paying below and follow the remaining instructions on this form to participate in the Amnesty Program.

Eligible Unreported Liabilities

In addition to receiving amnesty for eligible liabilities reflected on your SOA, you may also receive amnesty in connection with contributions due on wages not yet reported to the department or disclosed through an audit. In order to receive amnesty, you must file quarterly reports, or amended quarterly reports, for all calendar quarters in which the wages were paid (through the first quarter of 2012). Your reports must include each employee's name, Social Security number, amount of wages paid and the number of credit weeks earned. If you under report wages and/or pay less than the correct amount of contributions due, amnesty does not apply to interest and penalties on the unreported wages and unpaid contributions.
